# Consider the AGM format that best suits your company

With physical, hybrid, and fully virtual AGMs (subject to your constitution) all now well-established options - and no single industry preference emerging - it's important to choose the format that works best for your board, your shareholders, and your operational needs.

While many companies successfully combine in-person and technology elements, it's important to understand what formally constitutes a hybrid meeting. If you're unsure or would like to discuss your options, please don't hesitate to contact your Client Service Manager (CSM).



#### Lock in your AGM timeline early

Once your AGM date is confirmed, please notify your CSM as soon as possible so we can collaborate on an agreed timeline. Your CSM will arrange a planning session with you to discuss your specific needs, confirm the services required, and set key dates - particularly for the dispatch of securityholder communications.

Early confirmation of your AGM date helps us plan and allocate resources to ensure seamless delivery of your meeting.





If you're not already doing so, consider sending an AGM Access Letter instead of printing and mailing the full Notice of Meeting. This approach offers significant cost savings, especially given the consistently low number of shareholders opting in to receive the full document.

BoardRoom can provide various examples of letters in use to support your preparation.



## Tailor your approach for key resolutions

If your company has previously received a strike or is putting forward any resolutions not endorsed by the board, please speak with your CSM about enhanced wording or formatting options for your proxy form and online voting platform. These adjustments can help guide shareholders in lodging clear and informed proxy instructions.

Additionally, if you anticipate a close vote and wish to engage directly with retail shareholders, consider a targeted call campaign managed by BoardRoom's outbound communications team to help drive engagement and understanding.




